Submittal Requirements:

- Building Permit Application in a CD/USB in PDF Format– accompanied by:
 - Survey of property (plot plan showing as-built).
 - Swimming pool plans which include:
 - Plot plan showing location of the swimming pool on the property. This will designate the distances from property lines, utility easements, existing structures and other items as needed.
 - All systems which will be installed in ground (plumbing, electrical, gas or other) are to be shown on the plot plan and distance from pool and other structures to be shown.
 - Actual pool design and all items required must comply with 2015 “International Pool & Spa Code” and 2015 IRC.
 - The wall view including the beam, wall and floor of pool with rebar location and sizes used.
 - All information for the pool depth, distance from existing structures to the edge of the beam to be noted.
 - Minimum distance from existing structures to excavation is 5 feet. Closer than 5 feet an Engineer letter is required showing the pool proximity will not adversely affect the existing foundation(s).
 - The pool barrier location must be shown, its height and gate. The latches on the gate(s) must show the latch location and any special requirements.
 - Doors that provide access to the pool area must be properly alarmed as required. Please verify how the alarm requirements have been met.
