



Notice Regarding Case Record Requests

The City of Pearland Municipal Court periodically receives request for information contained in our case records. We are mindful of our obligations under applicable law to allow inspection of these records. To avoid confusion regarding our response to such requests, please note the following:

- Courts in Texas are not subject to the Texas Public Information Act thus requests for case record information are not governed by that law. Please see Texas Govt.Code §552.003.
- Information in case records may be requested and obtained as a matter of common law in Texas, and common law principles of confidentiality of certain personal information apply.
- As a matter of common law, this court has determined that the following information will not be disclosed:
 - Social Security Numbers
 - Driver's license Numbers
 - Addresses
 - Telephone Numbers
 - Financial Information
- This court will not provide information for a matter if the case file that matter has been destroyed in accordance with our records retention policy.
- Fees may be charged in accordance with applicable law.
- Although we are only required to provide printed records in person or via mail; requests for delivery by other means or in other formats will be considered on a case by case basis by the Municipal Court Supervisor whose decision is final.
- If you believe that the records you have requested fall under Rule 12 of the Rules of Judicial Administration and you are not satisfied with the response of this court to your request, you may appeal the decision of this court to the following entity in the manner prescribed by Rule 12.9 of the Rules of Judicial Administration:
